Definitions

Full Time Agency: Any agency organized for the purpose of providing recreation and park services for a particular community and aligning its aims and objectives consistent with those of the Georgia Recreation and Park Association, Inc.; shall not be entitled to vote. To be eligible for Agency membership an organization must employ a full-time, year round salaried director; sponsor a variety of activities, and programs as well distributed throughout the year; submit written aims and objectives.

Allied Agency: Any Agency or organization established for the purpose of maintaining the leisure needs or services of a specific population or a year round salaried leisure services administrator must be employed; shall set a plan of action suggesting a variety of activities to meet the community leisure needs; shall not be entitled to a vote or athletic membership; must be reviewed at the end of each membership year.

Board Commission: Members should only be those individuals who are elected or appointed to serve.

PROFESSIONAL: Any full-time employee in the field of recreation and parks or a leisure service professional, including those certified or licensed by state or national crediting organizations. Shall be entitled to all privileges of the association including the right to vote, hold elective office, and chair or serve on a standing committee.

ASSOCIATE: Any individual not eligible for a professional membership; (i.e. to include but not limited to administrative personnel, part time employees, seasonal employees, or company representative). Shall be entitled to all privileges of the Association except the right to vote, hold elective office and chair a standing committee.

STUDENT: Any individual currently enrolled full-time in a college or university as a candidate for a degree in recreation and/or related fields of study. Shall be entitled to all privileges of the Association except the right to vote, hold elective office, and chair a standing committee.

CONTRIBUTING: Any individual or organization that contributes \$100 or more to the association annually shall be allowed to vote.

The Association has established four (4) networks for members who have a common interest in a special area of the recreation and parks profession.
