Ask questions at the end of the presentation or use the Chat Feature. 2. In order to get credit, you must stay on the webinar for 45 minutes minimum and GoToMeetings must be at the front of your computer screen or else the report collected at the conclusion of the presentation will show that you were not present for any time when GTM is behind other items (email, etc.). 3. If you call on your phone and log in to your computer and then exit from one device, GTM will show that you are not present. You must stay logged in to both devices. 4.
